Steps to file an Article 27 Grievance

<u>Step 1</u>

DETERMINE IF THE GREIVANCE WILL BE FILED UNDER SECTION 1 PERMANENT RECLASSIFICATION OR SECTION 3 TEMPORARY WORK OUT OF CLASS

DEFINITIONS

Section 1 Permanent Reclassification : An assignment which causes <u>a significant</u> change in permanent job duties or job content.

Section 3 TWOC : Being temporarily assigned to perform in general the duties and responsibilities of a position in a higher rated classification that are separate & distinct from those of their own position. The assignment lasts for five full cumulative days in a calendar quarter.

CONTACT THE MRC AT 1-800-523-7263 TO START THE POCESS

AND SUBMIT PROPER DOCUMENTATION

<u>Step 3</u>

COLLECT DOCUMENTATION PERTAINING TO GRIEVANCE AND FORWARD TO THE MRC. PLEASE SEE THE ARTICLE 27 CHECKLIST FOR A COMPLETE LIST OF WHAT MUST BE SUBMITTED.

<u>Step 5</u>

MRC FILES THE GRIEVANCE

<u>Step 4</u>

SEND ALL DOCUMETATION TO THE EMAIL ADDRESS ON THE BACK OR TO COUNCIL 13 VIA US MAIL. A COMPELTED GRIEVANCE FORM AND FACT SHEET MUST BE SUBMITTED TO GET A NUMBER

<u>Step 6</u>

GRIEVANT WILL BE CONTACTED BY GRIEVANCE DEPARTMENT

TIMEFRAME

SECTION 1 PERMANENT:

- 1. ASSIGNMENT OF HIGHER LEVEL DUTIES WHERE THERE IS A SUBSTANTIAL CHANGE IN DUTIES.
- 2. NOT COMPENSATED IN NEXT PAYCHECK FOR HIGHER LEVEL WORK.
- 3. FILE GRIEVANCE

TIMEFRAME

SECTION 3 TWOC:

1. MEET THRESHOLD REQUIREMENT OF 5 FULL CUMULATIVE DAYS IN QUARTER 2. NOT COMPENSATED IN NEXT PAYCHECK FOR HIGHER LEVEL WORK 3. 15 DAYS FROM THAT DATE TO FILE GRIEVANCE
